# **PRIVACY POLICY**

This Site is owned, operated and maintained by KIMBERLY-CLARK CORPORATION ("Kimberly-Clark"). At Kimberly-Clark, we recognize that visitors to or users of our Site may be concerned about the information they provide and how we treat that information. This Privacy Policy addresses those concerns. The purpose of the Kimberly-Clark Privacy Policy is to describe how the websites and mobile applications owned or operated by Kimberly-Clark collect, share, and secure information. Before you provide us with any personal information or otherwise browse or use our Site, you should read through this Privacy Policy completely and make sure that you are comfortable with our privacy practices. We may update the Privacy Policy from time to time, so please check in occasionally.

#### **Information We Collect**

At this Site, you may choose to provide Kimberly-Clark with information about yourself that is "personally identifiable information." When we use the term "personally identifiable information," we mean information that is collected in conjunction with your name. Your use of this Site may provide other information about you that is not "personally identifiable information." This information is not collected in conjunction with your name. Kimberly-Clark does not collect personally identifiable information about you unless you provide it to us voluntarily and knowingly. You can choose not to use or visit this Site. However, if you give us personally identifiable information, such as by asking to be put on our mailing list or entering contact information, we may contact you from time to time.

You may connect with Kimberly-Clark or one of its websites through social networking websites, such as Facebook or Twitter. If you initiate such a process, such as by "Liking" a Kimberly-Clark product on Facebook, you will be allowing Facebook to provide us with information from your Facebook profile. Whenever submitting information on a social network website you should familiarize yourself with their privacy policy and practices.

#### **How Information is Collected**

*By Asking*. We may collect some information from you by asking that you provide it to us. For example, we may ask you for your email address on our Site, or require you to provide us with information such as your birthday, telephone number, and address, so that the Site can provide additional benefits or features or you can sign up for our rewards programs or request a free sample. Personally identifiable information is collected from you directly and with your knowledge.

*Cookies*. Like many companies, Kimberly-Clark may use "cookie" technology on our Site. Cookies are information stored on your computer or mobile device by your browser to save your preferences while you are visiting or using a particular Site. When you log in or open a Site, the cookie tells us whether you visited us before or are a new visitor or user, and it enables us to learn which advertisements bring users to our Site. The cookie doesn't obtain any personal information about you or provide us with any way to

contact you. We do use the cookie to help us identify Site features in which you have the greatest interest so that we can provide more of what you may want. If you choose, you can set your browser to reject cookies or you can manually delete individual or all of the cookies on your computer or mobile device by following your browser's help file directions. However, if you do not enable cookies to be received by your web browser, you may have trouble accessing some of the pages and certain features on this Site.

Web Beacons. A web beacon is an electronic file on a Web page that allows us to count and recognize users who have visited that page. Among other things, a web beacon can be used in HTML-formatted email to determine responses to our communications and measure their effectiveness – for instance, if you get an email from us and click on a link in that email to go to our website. You can generally avoid web beacons in email by turning off HTML display and displaying only the text portion of your email.

*Internet Protocol (IP) Address*. As you enter our Sites, we capture and retain the IP address of the device you are using, such as a personal computer or a mobile device.

*Mobile Applications*. You may also choose to download mobile applications offered by Kimberly-Clark. If you use our mobile applications, the mobile application may collect certain information automatically, such as the type of mobile device you use, the temporary or persistent unique device identifiers (sometimes called UDID) and information about the way you use the applications. The mobile application may also collect certain information you voluntarily provide, such as product information when you scan a bar code, and transactional information, such as when you make a purchase or respond to an offer. Our mobile applications may collect precise information about the location of your device, such as when you search for a store. However, you must first provide permission through your device before the application obtains such location information from technologies like GPS, Wi-Fi, or cell tower proximity. Mobile service providers may collect device-specific information, such as a unique device identifier, when you use our Site or one of our mobile applications.

### What We Do with Your Information

When you voluntarily sign up on this Site, we may add your name, email address and street address to our mailing list. If you do not wish to receive these mailings, you may request to be removed from our mailing list by calling 1-888-525-8373. Additionally, if you decide that you do not want to receive commercial emails from us, you can "opt-out" from receiving such emails by clicking on the "unsubscribe" link provided at the bottom of every commercial email. Please note that if you choose to opt-out, we will still send you email relating to specific products or services that you purchase or sign up for, or email that we believe is pertinent to any communication that you have sent to us. If you decide at a later time that you would like to receive commercial emails from us, you can re-add yourself to our communication list.

Our Site sometimes includes notices of sweepstakes or other promotions we are conducting, and we may permit you to send your entry electronically in some cases. If that occurs, we will use the information you provide for the purpose of conducting the promotion (i.e., to contact you if you're a winner).

#### **How We Share Information**

We may share information about you with third parties in certain circumstances including in the following situations:

Sharing Your Information With Partner Companies. We may ask your permission to share your information with carefully selected outside companies when we believe their products or services may interest you. You may "opt out" of partner offers and programs at any time by updating your User Profile, Contacting Us or calling 1-800-665-9773 (on weekdays during 8 AM to 4 PM Central Standard Time). Our partners are prohibited from using your contact information for purposes other than presenting relevant offers and programs, and they are required to maintain your contact information in confidence.

Sharing Your Information with Service Providers. We may share information with companies or individuals that provide us with services. These services may include, among other things, helping us to provide services that you request, to create or maintain our databases, to research and analyze the people who request products, services, or information from us, to prepare and distribute communications, or to respond to inquiries.

*Law Enforcement and Legal Process*. We may report to law enforcement agencies any activities that we reasonably believe to be unlawful, or that we reasonably believe may aid a law enforcement investigation into unlawful activity. In addition, we reserve the right to release your information to law enforcement agencies if we determine, in our sole judgment, that either you have violated our policies, or the release of your information may protect the rights, property, or safety of Kimberly-Clark, or another person.

Sharing Your Information as Permitted by Law. We may share your information with others as required by, or permitted by, law. This may include sharing your information with government entities, or third parties in response to subpoenas, court orders, other legal process, or as we believe is necessary to exercise our legal rights, to defend against legal claims that have been brought against us, or to defend against possible legal claims that we determine in our sole discretion might be brought against us.

*Blogs, Online Postings, and Testimonials*. We may decide to allow users to share comments, postings, testimonials, or other information. If you choose to submit such information to us, the information that you submit may be available generally to the public. Information that you provide in these areas may be read, collected, and used by others who access them.

*Business Transaction*. In the event that we, or any portion of our assets, are acquired or we undergo another transaction in our business, your information may be transferred to the acquiring company or other entity surviving such a transaction.

*Interest-Based Advertising*. Kimberly-Clark participates in interest-based (on-line behavior) advertising. This means that a third party may use technology, such as a cookie on your browser or a web beacon, to identify you on our website so that they can provide advertising about products and services tailored to

your interest. You may see advertising on our website tailored to how you browse or shop, or you may see advertising for Kimberly-Clark products on other websites based on your browsing behavior across websites. Kimberly-Clark voluntarily participates in the Digital Advertising Alliance self-regulation program. As part of this self-regulation program, Kimberly-Clark supports deployment of the Advertising Option icon ("Ad Choices") in partnership with Evidon.

*Other Third Parties.* We may share non-personal information with other third parties that are not described above. When we do so we may aggregate or de-identify the information so that a third party would not be likely to link data to you, your computer, or your device. Aggregation means that we combine the non-personal information of numerous people together so that the data does not relate to any one person. De-identify means that we attempt to remove or change certain pieces of information that might be used to link data to a particular person.

# Managing Your Privacy Through Your User Profile

We provide you with the ability to exercise certain controls and choices regarding how we collect, use and share your personal information. By changing your User Profile or contacting us as described within this Privacy Policy, you may do the following: (1) You may correct, update and delete your registration account; (2) You may change your choices for subscriptions, newsletters and alerts; (3) You may choose whether to receive offers and promotions for our products and services, or products and services that we think may be of interest to you; (4) You may choose whether we share your contact information with partners so they can send you offers and promotions about their products and services; (5) You may choose whether to receive interest-based advertising; and (6) You may request access to the personal information we hold about you and that we amend or delete it and we request partners with whom we have shared the information do the same.

Some web browsers and devices permit you to broadcast a preference that you not be "tracked" online. At this time we do not modify your experience based upon whether such a signal is broadcast.

### **Security Measures**

Kimberly-Clark takes reasonable and appropriate measures to secure your personal information once we receive it, and to help prevent it from being disclosed to individuals who are not described in this policy. While we follow reasonable procedures to try to protect the information in our possession, no security system is perfect, and we cannot guarantee, and you should not expect, that your information will remain secure in all circumstances.
